 - (iii) an article headed "Include Blacklisting in Undercover Police Enquiry" published on the Defendant's website www.gmbunion.org on 12 March 2015
 - (iv) an article headed "Bridgend Skanska Blacklist Protest" published on the Defendant's website and/or a website controlled by the Defendant www.gmbwalesandsouthwest.org.uk on 26 March 2015
- (b) an injunction restraining the Defendant by itself, its directors, officers, servants, agents, or otherwise from further publishing and/or causing to be published the same or similar defamatory matter of the Claimant.

Value

This is a claim for libel and so should be issued in the High Court in accordance with CPR PD 7A para 2.9
(1). The Claimant expects to recover not more than £10,000.
