Dear Ross,

I've just left you a voicemail and was hoping to speak to you ahead of sending an email.

At our meeting at the Council's offices on 6 November to discuss the scoping request for the above site we also discussed the planning status of the current siting of cabins, generators, water and fuel tanks, fencing/gates, cctv and matting on the land which you indicated had been done for security purposes. Thank you for providing a written response to my colleague John Cranham detailing what is on site, why it is there and your view as to the planning status of this.

I have now had the opportunity to view the site first hand from the perimeter and review the content of your letter. I can follow your train of thought which emphasises the salient points brought out by the case law relating to the issue as to whether an activity amounts to development or not and how these apply to the current activity at the site; however, balancing the facts relating to the site I consider that development has taken place, both in terms of operational development and change of use and that there has been a breach of planning control.

I am conscious that at the present time the site does not benefit from any minerals related planning permissions and that the only link to minerals development is through the current scoping request. As no minerals development has taken place at the present time it will be for the local planning authority, Bassetlaw DC to investigate further and determine how to proceed. I have forwarded a copy of your letter to Mr Wells, Bassetlaw DC's Planning Enforcement officer and no doubt he will be in contact with you once they have had the opportunity to visit the site and assess matters first hand. However, he has indicated that with the information which he has available to him at present that he too believes that what has taken place is development and that it is likely that a planning application will be invited to seek to regularise this development, this is of course subject to the conclusion of his own investigation.

Just so you are aware I have been approached by a number of parties who have sought clarification of the planning status of the current activity and will be advising them of the above.
