Unfortunately the majority of the information you requested cannot be disclosed as it is held by our Media Advisors who are a private sub-contracted company, and any communication/s they hold with CoRWM Members that does not channel via the secretariat (defra) is held as confidential - between two private parties.

I can however disclose information that the secretariat does hold within defra. In this case most of the information is in the form of electronic press cuttings and press reports. I attach a sample below. If you would like to receive these I will gladly post/email them to you.
