5. SECOND PATROL STILL MISSING, INCLUDES SOME BRITISH MERCENARIES, SAID TO BE "CULLEN'S MEN".
6. MCALEESE CONCERNED AT POSSIBILITY OF LEGAL PROCEEDINGS ON RETURN TO U.K. FOR HIS PART IN COURT-MARTIAL AND SUBSEQUENT EXECUTION OF COPELAND. RENNIE (PARA 1(VIII)) IS SAID TO HAVE BEEN WITNESS THAT COURT-MARTIAL PROCEEDINGS WERE "PROPERLY" CONDUCTED. DAVIES CONFIRMED MCALEESE HAS PHOTOGRAPHS OF BODIES AFTER MASS EXECUTION.
