Thank you for your e-mail dated 22/02/2010. As the information you requested is not personal or environmental it has been processed in accordance with the Freedom of Information Act 2000.

I have investigated your request and the answers to your questions are as follows. Below is a table which contains the total amount of funding for each organisation under Preventing Violent Extremism. Please note that Nottingham City Council received no funding of this nature in the financial year 2006/2007, so this table covers the period from then to present. Also, it is not known how much funding will be given to the projects in future – therefore in accordance with section 1 of this act this information cannot be provided as it is not held by this authority.
