- Slides 10, 11, 12 some members may well be interested in hydrogen economy, perhaps more of a broad overview - also perhaps you could combine the bottom half of slide 11 with slide 12 - Yucca Mountain opening and recommendation on second repository is of interest
- Agreed with deletion of slides 15-18, but keep 14, and perhaps 19 as final slide?

Richard:
